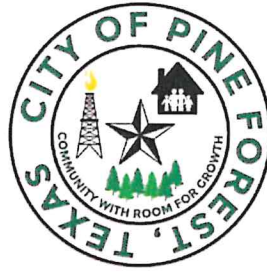
Greg Caldwell Spoke to council about stray animals and asked if there was anything they could do to help with the animals.


